Registration Policies

- US Cheer Productions reserves the right to close, combine, or open divisions at any time leading up to each event.
- A division change fee of \$50 will be charged for any division changes made after the “On Time” registration deadline.
- Division changes will not be allowed the week of the event. NO EXCEPTIONS.
- Team roster changes will not be allowed the week of the event.
- 75% refund or the option to transfer 100% of the funds to another USCP event in the 2020-2021 season will be available to teams withdrawing from the event prior to the “Early” registration deadline.
- 50% refund or the option to transfer 100% of the funds to another USCP event in the 2020-2021 season will be available to teams withdrawing from the event prior to the “On-Time” registration deadline.
- NO REFUNDS will be issued once the “On-Time” deadline has passed.
- All refund or transfer request must be submitted in writing and received by USCP by the deadlines listed above.
- NO REFUNDS OR TRANSFERS FOR INDIVIDUAL MEMBERS.
- Payment, Team Roster & Waivers must be received by the Thursday TWO WEEKS prior to the event in order for the team to be included in the random drawing for the Performance Order. If a team is not paid in full by this deadline, the team will not be added and the team will perform first in their division. The performance schedule will be released to coaches once it is available.
- Changes to the performance order may be approved and will be at the discretion of the USCP staff within a short window of time after the release of the schedule. However, NO REQUEST TO CHANGE PERFORMANCE ORDER WILL BE ACCEPTED 10 DAYS PRIOR TO THE EVENT.

Crossover Definition

1st Team is Full Price per Participant

2nd Team Crossover is 1/2 Price per Participant

3rd Team Crossover is Free per Participant

*A "crossover" is a cheerleader/dancer that competes on more than one team for the same gym/school and at the same event. The crossover pricing does NOT apply to a participant who is on a school team and an All-Star Team.
